## **WOLCOTT LIONS AGRICULTURAL SOCIETY FAIR**

### **RULES FOR 2018 COUPLES BACKSEAT DRIVER CHALLENGE**

1. Participants each must be at least 21 years of age.
2. Each participant must sign the hold harmless agreement on the application form.
3. Participants may not be Wolcott Lion's Club members.
4. The operator must drive through the designated course as set out for the event and shall be timed from the start. The couple completing the course in the least amount of time (including time added on for penalties) shall be the winner.
5. The driver must wear a blindfold and remain blindfolded throughout operation through the course.
6. The passenger is only allowed to verbally direct the driver through the course and may not touch the steering wheel, brake or acceleration pedal at any time.
7. The golf cart may only be driven forward and shall not be placed in reverse.
8. The driver must drive through each and every gate (cones). For any gate missed the couple shall operate the golf cart around and through the gate before proceeding to the next gate. Intentionally running over gates without attempting to properly pass through the gate will be a disqualification.

9. Should the driver strike any cone and knock it out of place, the driver must maneuver back around and through the gate before proceeding to the next gate.

10. The event shall be limited to the first twenty (20) couples whose applications are accepted and approved and who register at the fair at the time of the event.

11. Email applications are to be completed and returned to Lion Roger Harbanuk no later than 4:00 pm on Wednesday, August 15, 2018 at [s.borghesi@snet.net](mailto:s.borghesi@snet.net).

Additional applications will be accepted by Lion Roger Harbanuk or his designee at the Lion's Club Fairgrounds at the Lion's Pen Arena up until 4:45 pm on Sunday, August 19, 2018 or until such time as 20 couples have been registered but no later than 5:00 pm on that date.

12. Couples shall register at the Lion's Pen Arena on the day of the event commencing at 4:45 pm. Proof of age is required.

13. The Wolcott Lions reserve the right not to allow participation in the event of any person who appears to be under the influence of alcohol and/or drugs or who appears to be incapable of safely operating a golf cart at this event.

14. Any participant who is determined to be acting recklessly will be disqualified and asked to immediately leave the arena.

15. In the event that time permits, the driver and the passenger will be required to switch the driver and passenger positions for a second run and the times plus penalties, if any, will be accumulated.

16. In the event of any tie, additional runs will be required to determine the winner. During the additional runs, the couple may choose who the driver and passenger will be.

17. All participants must pay the entry fee to get into the fair.
