**IMPORTANT NOTE:**

Our definition of a “Crafter” is someone who *purchases or manufactures components and then builds/constructs/assembles these components into a finished product (50% hand made)*. If you are purchasing a finished product for resale, then you are not a “Crafter” and you should instead be applying as a “Commercial Vendor”.

Your product(s) will be examined and verified that they were created/made by you. If you bring commercially made products to resell, you will be moved to a commercial space and must pay the difference in price for the available space. If no commercial space is available, you will not be allowed to sell product on the fairgrounds. Your application will be approved or disapproved at the discretion of the Fair Chairman.
