NOTE: No entries will be accepted without entry fee and completed W-9 Form.

General Rules:

- 1. Entries close July 30th, or until cages are full.
- 2. Entries limited to 40 birds per family. Limited to *first* 250 birds.
- 3. All entries must be owned by exhibitor.
- 4. Judging will be by the "Standard of Perfection". The decision of the judge is final, any interference with the judge may be reason for disqualification of entire entry.
- 5. Entry fee: 1-4 birds is \$5.00. Each additional bird is \$.50/bird. Exhibitor is entitled to 3-day fair pass.
- 6. Only adult birds 6 months or older may be shown.
- No more than 2 cocks, 2hens, 2 cockerels, or 2 pullets of the same variety may be shown by the same exhibitor.
- 8. All birds must be tested for Pullorian Typhoid and AI. You must submit proof when submitting your entry.
- 9. Judging is at 10:00AM on Saturday. All entries must remain until 6:00PM on Sunday.
- 10. You must bring birds in from 4:00PM-8:00PM on Friday.
- 11. Feed and water will be furnished by the Wolcott Country Fair.
- **12**. When entering, please state: Breed and Variety, Ck, Hen, Ckl or Pullet, Standards, Bantams, or Waterfowl.
- **13**. The Wolcott Country Fair and the Poultry Committee will not be responsible for accidents, mistakes, loss or damage from any cause.
- **14**. No telephone entries will be accepted.
- **15**. Make sure your name, Social Security Number, address & telephone number are on your entry and that your entry fee accompanies the entry. Submit completed W-9 Forms if not done previously.
